RESOLUTION #2016-

**APPROVING THE ELECTION RESULTS
FOR THE NOVEMBER 8, 2016 MUNICIPAL ELECTION
BY THE CANVASS BOARD FOR THE CITY OF PARK RAPIDS**

WHEREAS, in accordance with the Park Rapids City Code, Chapter 30, Section 30.01 and 30.02, a Municipal General Election for the Mayor, with a two (2) year term, and two City Councilmembers, each with a four (4) year term, is required to be held in the evened numbered year of 2016; and,

WHEREAS, the 2016 Municipal Election, held on Tuesday, November 8th, 2016, in accordance with Resolution #2016-02, Setting Guidelines for the City of Park Rapids Municipal Election in 2016, as adopted by the City Council on January 12th, 2016; and,

WHEREAS, according to Minnesota Statutes 205.185, Subdivision 3, the City Council shall act as the Canvassing Board for the City of Park Rapids to canvass the returns, and certify the municipal election, between the third and tenth day following the general election, and the governing body of a city shall declare the results of the election; and,

WHEREAS, the results of the election for the office of Mayor, with a two (2) year term, two Councilmembers, each with a four (4) year term, all at large, are as follows:
