RESOLUTION #2018-
APPROVING THE ELECTION RESULTS
FOR THE NOVEMBER 6, 2018, MUNICIPAL ELECTION
BY THE CANVASS BOARD FOR THE CITY OF PARK RAPIDS

WHEREAS, in accordance with the Park Rapids City Code, Chapter 30, Section 30.01 and 30.02, a Municipal General Election for the Mayor, with a two (2) year term, and two City Councilmembers, each with a four (4) year term, is required to be held in the evened numbered year of 2018; and,

WHEREAS, the 2018 Municipal Election, held on Tuesday, November 6th, 2018, in accordance with Resolution #2018-07, Setting Guidelines for the City of Park Rapids Municipal Election in 2018, as adopted by the City Council on January 9th, 2018; and,

WHEREAS, according to Minnesota Statutes 205.185 subdivision 3 (a), the City Council shall act as the Canvassing Board for the City of Park Rapids to certify the returns and declare the results of the municipal election to the county auditor, between the third and tenth day following the general election; and,
