CITY CODE: CHAPTER 115.08 PERMITS: No plumbing systems, equipment or fixtures shall be installed contrary to this Chapter within or on any building, structure or premises, publicly or privately owned, nor shall any alteration or addition thereto or to existing fixtures, equipment or systems be made without first securing a permit therefore from the City. No permit will be required to execute any of the classes of plumbing work specified in the following paragraphs:

1. Public service corporations shall not be required to obtain permits or inspection, for work upon or in connection with their own properties.

2. Manufacturers shall not be required to obtain permits or inspection for work incorporated within equipment as a part of product manufacturing. Application for permit describing the work to be done, shall be made in writing to the plumbing inspector by the person, firm, or corporation installing the work. The application shall be accompanied by plans, specifications and schedules as may be necessary to determine whether the installations as described will be in conformity with the requirements of this Chapter. If it shall be found that the installation as described will conform with all legal requirements and if the applicant has complied with all provisions of this Chapter, a permit for installation shall be issued.

All plumbing systems for commercial buildings shall be submitted to the state for review and approval unless the Plumbing Inspector has agreed to accept the drawings for small remodeling projects without submission to the state.

PERMIT FEES SHALL BE AS FOLLOWS: \$25.00 Piping and first 5 fixtures; \$2.00 each additional fixture, plus \$1.00 state surcharge. Meter prices vary by size.

If re-inspection is necessary for work not done, or the work does not meet the test requirements, a fee in the amount of \$25.00 shall be charged the Plumbing Contractor to whom the permit was issued for each re-inspection necessary. Notification for inspection must be made in compliance with the Minnesota Plumbing Code.
